The Council will light up the clocktower in Epsom Market Place in purple in memory of the victims of the Holocaust and genocide worldwide.

The Mayor, Councillor **Clive Woodbridge**, will give a speech which will be available to view on the Council's YouTube channel from Friday - <https://www.youtube.com/channel/UC0UGt6AEUCYhS3gjs4jEsysg>.

An exhibition will take place at **Bourne Hall**, Ewell, looking at the history of the Holocaust and linking it to local stories from the Borough. Visitors will be able to place LED candles on the shrine as a mark of respect.

## Local Parking (enforcement) Wars

An opinion piece from **Cllr Eber Kington**: This week SCC announced a seven-year contract worth £96.5 million, with private company Marston Holdings Ltd, for parking and traffic enforcement. In April, SCC will be centralising parking enforcement, a service which currently is managed by Surrey's Borough and District on behalf of the County.

The accompanying comments to the announcement, made by the Kevin Deanus, Cabinet member for Highways and Community Resilience, promise much. But residents need to be aware, SCC does not have a great track record when it comes to taking back decision making and centralising services previously provided by the Borough Council on behalf of the County.

When SCC took back the maintenance of highway verge trees the policy became one of no maintenance unless a

tree is diseased, dying or dead. And no longer will SCC automatically replace a tree lost to our urban streets. Instead, our residents have to pay £25 just to get a location looked at. £25 which is not refundable and, as often is the case, ends with the site being declared as unsuitable for a tree.

In April, SCC is also taking back the cutting of verges. The 6 to 8 seasonal cuts by the Borough Council, recognising seasonal weather conditions, will be reduced a standard county-wide cut of 4. Hardly an upgrade on what has gone before. And will SCC be pro-actively managing overhanging branches in our urban alleyways? My concern is that SCC does not even realise it's a job to be done.

And the abolition of Local Committees and centralisation of highway decisions. Now residents have no public meeting to ask questions of Highway Officers, petitions are determined at SCC's HQ in Reigate by council officials or a SCC Cabinet Member, and road safety schemes are decided by a Cabinet Member rather than local County Councillors.

So, what will this £96.5 million contract mean? Kevin Deanus, Cabinet member for Highways and Community Resilience, said: "The new contract will mean that Surrey County Council can more directly and consistently manage on street parking enforcement across the county, helping to tackle inconsiderate parking and make parking restrictions more effective."

We all want safe and considerate parking, and there has to be a penalty for those who do neither. But that £96.5 million contract has to be paid for somehow. Will we see parking meters introduced where currently there are 1 hour or 2 hour waiting limits? Will additional yellow lines, designed to push drivers into paid for parking spaces, be introduced. Will the new system be flexible enough to ensure that our local primary schools are visited regularly to manage dangerous parking and idling cars? And will Residents Parking Zone Permit charges go up once again.

Personally, I'm not sure that SCC's desire for consistency and effectiveness in parking enforcement also equates to fairness in delivery and a recognition of local needs, and it won't be just another way to make our residents pay.

## Local Plan battle heating up?

A draft **Local Plan**, that will delineate **Epsom and Ewell Borough's** planning framework for decisions on planning applications and development for the years ahead, has been published on the Council's website. Out of 5,400 new homes proposed in the Draft Local Plan (2023-20240), some 2,175 homes (almost 41%) are earmarked to be built on the borough's Green Belt land. EEBC councillors are due to take a final Section 18 publication decision on 30 January,

Of nine "Preferred Option" development sites proposed, five are Green Belt - with Downs Farm, where 650 homes were proposed, only narrowly missing the cut after a campaign by residents. Over 55 hectares - or some 137 acres - of Green Belt land could be sacrificed. The plans include one gigantic estate of some 1,500 homes on land around Horton Farm, which will have its Green Belt status stripped away.

The "Preferred Options" for Green Belt development are:

- 150 homes around West Park Hospital
- 1,500 homes around Horton Farm
- 25 homes next to Chantilly Way
- 350 homes on the sports fields by Ewell East Station

- 150 homes on sports pitches at Hook Road Arena (land owned by the Council)

A spokesperson for a local campaign group seeking to protect green belt land has responded: *“Given the Government’s “brownfield first” brief, it looks like the planners did not get the memo. They certainly did not get the new memo from Government saying that it is not necessary to review Green Belt for housing. And they appear not to have taken the hint from neighbouring Elmbridge, who creatively avoided any Green Belt destruction, and Mole Valley, whose councillors this month voted unanimously to remove all Green Belt sites from its Local Plan.”*

*“Only on its own land can the Council specify 100% affordable homes – the rest will be about 40% , as developers have many canny ways to get round this stipulation and build more profitable higher end housing. The Plan is offering just around 1,000 homes in Epsom Town Centre until year 2040, with a similar number only on other brownfield spaces, plus also around 1,000 for planning permissions in the Borough already in the pipeline “*

Appendix 4 of the draft Local Plan reveal other Green Belt sites that have been offered up by developers in a “ Call for Sites.”

**Yufan Si**, campaign leader for **Keep Epsom & Ewell’s Green Belt** stated: *“So where is the real challenge taken up, to redevelop Epsom Town surroundings, which most commentators agree could do with some rejuvenation? The Kiln Lane and Longmead industrial areas are said to be off limits, according to consultants for EEBC, because of the 1,800 jobs there. So not a single new brownfield affordable home is put forward here, with no imaginative plan to mix housing with job creation and revitalise an area close to the station, shops and entertainment facilities that many people prefer.”*

*“We are left with the conclusion that the planners – and by extension our ruling Councillors – are in a “Call for Sites” trap. This has inhibited visionary thinking and pro-active engagement with urban developers on how much-needed affordable housing might be built in tandem with an exciting redevelopment programme that Epsom’s brownfield areas so desperately need. All they seem able to do about it is to bulldozer yet another field of our Green Belt heritage”* said Ms Si.

If Councillors vote at the special meeting of the Licensing, Planning and Policy Committee on January 30 for the Draft Local Plan (Section 18) to proceed, then it will be formally published by EEBC on February 1, followed by a six-week Public Consultation stage.

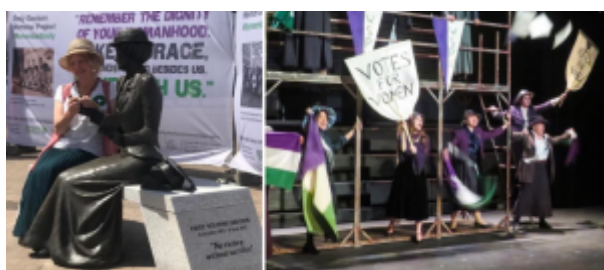

# Landlord thrashes tenant in friendly fight

**Epsom and Ewell FC 0-5 Leatherhead FC** - Mid-Season Friendly - Saturday 21st January. An Epsom and Ewell team that hadn't played a match for nearly three weeks came up against a Leatherhead side that had played fairly regularly during that period and in front of a crowd of 79, the score line of 5-0 to our opponents came as no real surprise.

With our League match against Arundel postponed, a friendly against our landlords on the artificial surface at River Lane, Fetcham was hastily arranged and kicking off at 2pm we gave a run out to our new signings Roan Strong, Musa Beegun and Rory Edwards while the majority of our regulars all played too, but for large parts of the game we found chances extremely limited. A change in formation just after the half hour made things a little more even for a while, but by then we were already two goals in arrears and three more followed in the second half.

The first goal came courtesy of a slight deflection, enabling the ball to creep past the wrong footed Strong in the 13th minute and a second followed after a great turn from the Leatherhead 10 which put him through to find the 9 with a good pass and he guided the ball past Strong into the bottom far corner.

The second half produced a slightly harsh score line for us as the Leatherhead keeper made three superb saves in the second half, two of which came from Nick Wilson, but to be fair, they also had other chances that weren't taken and could have had a couple more themselves. The third goal came in the 49th minute and was harsh on Strong who made a good save, only to see an opponent reach the loose ball first for a simple finish. A spectacular fourth goal then followed in the 67th minute with a strike from the edge of the penalty area that grazed the bar on its way in. All we had in response was one near post shot from Athan Smith-Joseph after he had received a long kick from Strong, but the keeper kept it out.

We then had three chances in a minute; the 75th, as it turned out. Firstly, Wilson struck at goal with a slight deflection on the way, requiring a great full stretch save to claw the ball away. From the corner, Thomson Adeyemi's header from point blank range was also kept out and the from the next corner Aaron Bogle struck over the bar from just inside the box.

A great deep cross from Athan Smith-Joseph was met by a superb volley from Wilson, but this was also acrobatically kept out by the Leatherhead keeper and an 86th minute penalty from Junior Kadi, after Bogle had brought a striker down just

inside the area, completed the scoring. You couldn't argue with the decision and seeing as the referee was our former Captain Alex McKay, it is only fair to say that he had an excellent game.

We now face another two weeks without a competitive match before hosting Oakwood, but this should give time for our new signings to become a little more familiar with the rest of the players as we finally commence the second half of our season against teams of not such a high standard.

# Going potty about pot-holes?

Who knew that 15th January was **National Pothole Day**? Earlier this month I drove around a bend in Woodcote Green Road in **Epsom** at night to be faced with a traffic cone placed a few feet into the road. Was that dangerous or was I lucky? The cone was placed in a large pothole and if the car had hit the pothole it might have been damaged. The Autocar website recently reported that a single pothole in Surrey had caused wheel and tyre damage to at least twelve cars on the evening of the 17th January. Whilst both the pothole that caused the damage to the 12 cars and the pothole in Woodcote Green Road were repaired by Surrey County Council, the surface on Woodcote Green Road leaves a lot to be desired and has done so for a number of years.

This incident reminded me of a report made to the Council via their pothole reporting web page in October of last year. It reported potholes and commented on the general poor state of the road surface of Woodcote Green Road that runs behind Epsom Hospital and is a route used by many cyclists. A reply was received. "We have visited the site and on closer inspection the problem does not need immediate work. We will continue to monitor and consider it when planning future works."



Cable exposed by pothole

Although Surrey County Council sends teams out to repair potholes they consider dangerous, the general surface of the road continues to deteriorate. On a stretch of Woodcote Green Road between Sunnybank and Pine Hill, about 450 metres long, more than 60 defects in the road surface are apparent. Some of these are no more than 2 cm wide and 10 cm long. One varied in width from a few centimetres to about 15cms, was 17 meters long and entirely in a cycle lane. Another was about a square meter in area and had cable exposed arising from and disappearing back into the road surface. Reporting a pothole shallower than 3cms or other road surface issues results in the message: "This issue is likely to be assessed as a low priority when inspected. We will probably wait to repair it as part of future improvement works."

Walking along the road it's noticeable that a number of defects are immediately adjacent to previous repairs, others are repairs that are beginning to break up and some are surfaces that have been reinstated after work by utilities and are sinking. Are the quality of repairs or reinstatements monitored and who is responsible for any substandard work?

It is also noticeable that when a team is sent out to repair a pothole, that is exactly what they do. There may be defects very close to the pothole being repaired but these are ignored. In wet and cold weather, even small holes in the road surface will fill with water, the water freezes and expands and the hole gets bigger. Would it not make sense, and maybe save money if once a team was on site they fixed not only the hole they were sent to fix but also other defects nearby?

The link to a map of planned improvements mentioned above indicates that no resurfacing work is planned for Woodcote Green Road. The map indicates that very little road resurfacing is planned for Epsom with only a little more in Ewell and Stoneleigh.

The wait goes on for better quality road surfaces in Epsom.

## Bassetts hound Sutton & Epsom

**Sutton & Epsom RFC 5 - Royal Wootton Bassett** 26. 21st January. Sutton & Epsom had travelled to Wiltshire in October to take on the winless Royal Wootton Bassett and returned to Surrey with their tails between their legs having lost 31-29. So the return fixture at Rugby Lane saw the bottom two clubs, with only two wins each this season, desperately slugging it out to grasp a lifeline to stay in Regional 1 South Central. For both clubs every match is of critical importance in their fight to retain their status but the coaches, players and supporters would have eyed this fixture as one to win. At the full-time whistle it was RWB who were triumphant in the relegation battle winning 26-5.

Rugby Lane was bathed in sunshine on an afternoon where the hard ground had claimed half of the league fixtures that afternoon. S&E gave a debut to Alex Mawdsley in the centre and Lawrence Elliott and Jack Howes, who were replacements against London Welsh, started. Jamie Flatley’s kick off was plucked from the sky by the S&E pack and Sutton were immediately on the attack. A penalty was kicked into the corner and Josh Glanville gathered the line out and was stopped a metre short. The forwards inched their way under the posts before it was spun wide to Robbie Martey to nip over in the corner. Though Freddy Bunting’s conversion slid by it was an ideal start for the Black & Whites who led 5-0.

The Wiltshire All Blacks response was instantaneous. They matched S&E by regaining the restart and also winning a penalty with the only difference being they went for the quick tap. Scrambling defence denied the initial surge before the ball was delivered to the opposite touch where flanker Scott Parry crossed untouched. Rhys Floyd added the extras for the visitors to take a 7-5 lead. Royal Wootton Bassett pressed hard to extend their advantage and endured a series of near misses as they failed to exploit an overlap and were also held up over the line. It was one-way traffic and deservedly at the end of the first quarter flanker Ollie Baycroft scored for RWB. Rhys Floyd missed the conversion but his team were well worth their 12-5 lead.

Sutton were struggling to gain any fluency despite the upper hand in the set scrum and a fully functioning line out. The hosts’ best opportunity to level the scores came on the half hour with some exquisite footwork from Jamie Flatley. The diminutive 10 jinked his way from halfway to five metres from the posts but his pass was knocked on under the pressure of the scrambling defence. For the remainder of the first half the Black & Whites were the architects of their own misfortune



as they tried to attack from their own 22 and conceded possession. However, despite the visitors dominating territory and possession they had to be satisfied with the 12-5 interval score.

RWB opened the second period by kicking a penalty to the hosts' 5-metre line. Sutton stole the line out but an inadequate clearance was returned with menace only for the alert Kyren Ghumra to secure the loose ball. The Black & Whites were struggling to find any sustained pressure as their opponents continued to search for a third try. The Wiltshire 10 entered flamboyant mode. First Rhys Floyd chipped over the top and re-gathered the ball in the 22 but was enveloped by the cover. Then a cross-field kick was added to his expanding repertoire. With Wiltshire winger favourite to score a cruel bounce denied the visitors.

Sutton & Epsom were clinging on by their fingernails but 15 minutes into the second period the pressure finally told. A sweeping attack was halted 10 metres short but a perfectly timed and angled run from the outstanding Number 8 Gavin Ougan saw him score. Rhys Floyd impressively converted from the flank for a 19-5 score-line. At this stage the Sutton resistance was being led by bullocking runs from Stefan Cooksammy who had replaced an injured Robbie Martey in the first period but there was very little fluency in the S&E game. Then at the start of the final quarter the Black & Whites arose from their slumber. Their best play saw Kyren Ghumra denied in the corner by a fine cover tackle. Then from a 22-metre line out the Surrey men attacked the left hand corner before switching to the wide-open spaces on the right. A try looked a certainty before an unforgiving pass left a brace of backs staring at the undefended line.

With the chance for a grandstand finish and memorable comeback fading by the minute it was Gavin Ougan that steadied the nerves of the Wiltshire All Blacks. Whether picking the ball up from the base of the scrum or receiving the ball in open play he rampaged forward clocking up the yardage to put Sutton on the back foot. With ten minutes left remaining RWB secured their fourth try and the bonus point that their superiority on the day warranted. Attacking from a line out on the S&E 22 they won a penalty 5 metres from the line. A couple of phases later winger Jamie Murray was over in the corner. Rhys Floyd made light of the angle to bisect the uprights for 26-5. The hosts were left playing for pride as they sought out a consolation score or two. A beautifully weighted kick from Jamie Flatley from 40 metres initiated a curious moment. The RWB cover gathered the ball near his line and passed it to an S&E player who immediately passed it to back to another RWB man, it was becoming one of those afternoons for Sutton. From a 5-metre scrum the retreating Wiltshire pack conceded a penalty. The Black & Whites spread themselves wide and from the tap penalty were held up over the line. The hosts returned the drop out from under the posts and nearly scored in one corner before switching directions. Jamie Flatley was in a promising position threatening a score but lost his footing and a grateful defence swallowed him up. The referee then ended the contest with Royal Wootton Bassett victors to the tune of 26-5.

With this result for Sutton the thought of relegation has shifted from possibility to probability with this crucial defeat to the side that sit at the foot of the table. In contrast RWB will be not studying the '3 Rs' but the '4 Bs' as they have fixtures against Bracknell, Banbury, Brighton and Bournemouth as the plot their route to survival. The visitors thoroughly warranted their success and will hope to maintain their momentum they have gained since the prolonged festive break. In contrast the Black & Whites remaining fixtures are predominantly against those teams in the upper echelons.

Next Saturday S&E will be visiting new territory when travelling to Horspath to play against the Oxford Harlequins. In the reverse fixture the Rugby Lane crowd saw a thrilling contest that the Oxfordshire side edged by 22-19.

## **Flight of refugees: history repeating?**

26 January 2023



**Epsom and Ewell Times** marks **Holocaust Memorial Day** (Friday 27th January) with an article about Surrey characters who saved Jews from persecution *and* we report on the work of a daughter of a Holocaust survivor, now living in Epsom, who is saving *today's* refugees.



Marking Holocaust Memorial Day (27th January) Surrey History Centre highlights local characters who saved Jews from persecution. Across Britain many so-called ordinary people made extraordinary and often brave attempts to help rescue and settle people escaping Nazi oppression. Surrey was no exception: individuals and committees alike demonstrated remarkable compassion and team spirit in helping refugees during the 1930s and 1940s.

Some of these extraordinary people were themselves Jewish refugees from Europe: people like childcare specialist, Alice Goldberger (1897-1986) from Berlin, who set up a hostel for child Holocaust survivors at Weir Courtney in Lingfield in 1945; Dr Hilde Lion (1893-1970), an academic from Berlin, who established Stotley Rough School in Haslemere in 1934; and Julius Warschauer (1907-1982) from Berlin who chaired the Mayor of Guildford's Refugee Committee, and was helped in the pastoral care of Guildford's Jewish refugees by his father Rabbi Malwin Warschauer (1871-1955).

### History repeating?



**Nina Kaye**, who lives in Epsom and is one of the founders of the **Epsom & Ewell Refugee Network**, is the daughter of a Holocaust survivor. Her mother, Marianne, was born in Vienna in 1925 and had to flee when the Nazis annexed Austria in 1938. Marianne's mother was granted a visa for Great Britain but she was not permitted to bring any dependents with her, so Marianne had to apply for a visa for the kindertransport and, at the age of 13, travelled alone from Vienna to Stockholm. Later, in 1943, she was able to rejoin her mother in London.

In 2015, Nina wanted to offer Syrian refugees a room in her house but there was no organisation that matched refugees with private families offering to host them. So she helped set up Refugees At Home ([www.refugeesathome.org](http://www.refugeesathome.org)), a charity that has since become one of the leading organisations to match people with a spare room to refugees and asylum seekers in need of somewhere to stay. Since then she has



hosted more than 30 refugees in her home.

At the same time she was involved in setting up Epsom & Ewell Refugee Network (EERN), a local organisation whose aim is to help support refugees and asylum seekers in and around Epsom. EERN is a volunteer led local organisation with an enthusiastic support network. Before the Ukrainian crisis, EERN was helping around a dozen families and some individuals settle in to the area and make a new life for themselves, providing English lessons, offering support to find jobs, helping children settle into schools, organising events and addressing many of the issues that arise. Since the war in Ukraine started, EERN now support around 180 families, helping them integrate into the community. Host families in this area have been very kind and generous and EERN offers support to both the families and their guests.

## Green-belters seeing red on Local Plan?

26 January 2023



A determined group of Epsom & Ewell residents, representing over 1,700 petitioners, took to the podium at last night's meeting of the Council's Licensing, Planning and Policy Committee (January 19th). They asked Councillors eleven questions about the threat of Green Belt sites being included as "Preferred Options" in the imminent Draft Local Plan.

[Official Council record: The Chair (Cllr **Steven McCormick** - RA Woodcote Ward) provided an oral response to each question. Eight supplementary oral questions were asked. The Chair, the Interim Director of Environment, Housing and Regeneration, and the Planning Policy Manager provided oral responses to seven of the supplementary questions. The Chair confirmed a written reply would be provided for one of the supplementary questions.]

Otherwise the business of the meeting was confined to approving increases between 6 and 10 % for 2023/2024 on a range of Council charges relating to Planning matters, private hire vehicle licensing, animals and scrap metal.

Given every indication that the Government no longer thinks Green Belt reviews are necessary with housing targets advisory only, and fresh from Mole Valley District Council's unanimous vote to remove Green Belt sites from its Local Plan, residents challenged the councillors and planners to seize the opportunity to save the Green Belt now and focus on brownfield sites for new affordable homes.

In answer to one question about whether planners had consulted HM Inspectors about Green Belt removal, council officers confirmed that, as EEBC was at an initial stage of decision taking, they had no need to consult the Inspectorate at this time, unlike Mole Valley are now required to do.

Given this difference, residents believe that it will now be entirely the responsibility of Councillors - the majority of whom are Residents Association, if Green Belt land ends up being developed. According to the Council for the Protection of Rural England, over 99% of sites earmarked for development by local authorities eventually get built upon, so the campaigners say it is both crucial and necessary to ensure no Green Belt sites are included at the outset.

The group intend to return to make more representations at the final decision-taking meeting on January 30 before the EEBC Draft Plan is published on February 1.

**Chris Grayling** MP for Epsom and Ewell has written to constituents: "There have been two new developments on the Local Plans which shape the future of housing development in our area - in Epsom and Ewell and Mole Valley.

Epsom and Ewell Borough Council is due to publish its draft plan in the next few days (sic), and this will show the degree to which it has decided to push for development on local green belt land. I very much hope they have chosen to focus on brown field sites and particularly on the potential for the Kiln Lane and Longmead areas.

Meanwhile in Mole Valley, the Council has asked the Planning Inspector to delay consideration of their plans, following the Government's revision of its national planning policies. It is too early to know if this may affect the plans for Ashted, but I will keep you posted."

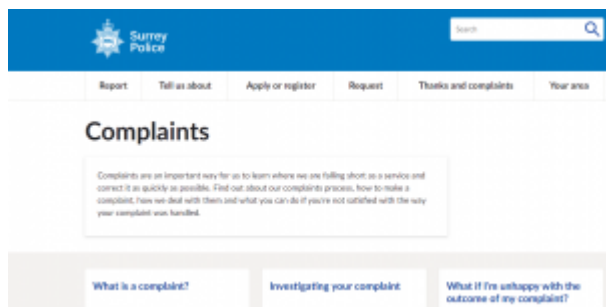

## Surrey Police Top Complaints Table

Surrey Police received more complaints per officer in its force than any other in England and Wales. The Home Office recently published the statistics for the year end 31st March 2022.

Epsom and Ewell Times has analysed the tables and the top forces are as follows:

**Lisa Townsend**, Police and Crime Commissioner for Surrey, said: “My office has been in detailed discussion with Surrey Police following the understandable concerns that the public may have following the national news this week. There is no place for misogyny or abuse of any type in Surrey Police and I have been clear with the Force that I have the highest expectations of our police officers.

“I am pleased that Surrey Police have rigorous processes in place to discourage all forms of behaviour that fall below the standards we have of every officer, and I am confident that all cases of misconduct are carried out with the utmost seriousness when an allegation is made either externally or internally. The latest quarterly data from the IOPC to last September shows a reduction in complaint cases against police officers in Surrey. However it is important to note that while every case is taken seriously, the total number of complaints received relates to a wide variety of themes. Many complaint cases are resolved to the satisfaction of the complainant.

“My office continues to play an important role in scrutinising the Force in all areas of performance, including regular meetings with Surrey Police’s Professional Standards Team and the IOPC. This includes identifying trends and working to improve the timeliness and quality of the service that every complaint receives.”

**Helen Maguire** Liberal Democrat PPC for Epsom and Ewell said: “As a former Royal Military Police Officer, it goes without saying that I fully support the difficult work that Surrey Police do. However, following the conviction of David Carrick, these Surrey figures will be seen locally as being very disturbing and so the public needs reassurance. Therefore Surrey Police Force must ask themselves why they are top of the table and how do they investigate internal complaints against their own police officers. That can only be achieved if there is external scrutiny of the figures – the public will not take kindly to seeing Surrey Police marking their own homework!”

**Mark Todd**, Chair of Epsom and Ewell Labour Party said: “In Epsom & Ewell we get a terrible deal on policing, so it’s no wonder that complaints are so high; and the huge problems at the Met show that the problems go wider still. During austerity the Conservative Government cut our police funding by 20% and Epsom’s police station was closed. It lies derelict on Church Street with just a small base during working hours at the town hall. We need a properly resourced, trained and managed police force and that’s what a Labour Government would provide. Currently our police force is not fit for purpose and it’s all the Government’s fault.”

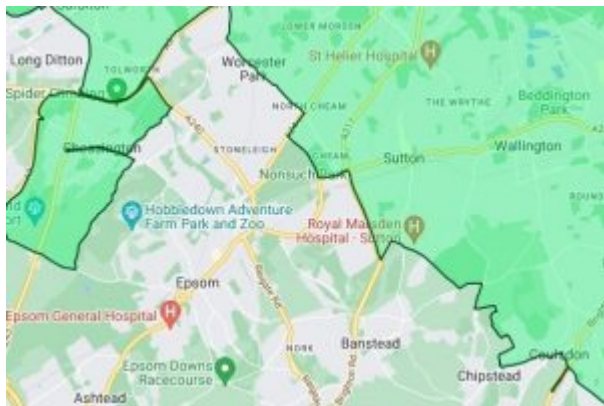

# ULEZ will come to Epsom and Ewell borders

26 January 2023



London has an air quality problem. That's why the Ultra Low Emission Zone (ULEZ) is expanding across all London boroughs from 29 August 2023 to help clear London's air.

Poor air quality is not just a central London problem. In fact, the greatest number of deaths related to air pollution occur in outer London areas.

The ULEZ has already made a significant difference, helping to reduce harmful nitrogen dioxide pollution by nearly half in central London. But we need to act now to help give the five million Londoners in outer boroughs clearer air to breathe too.

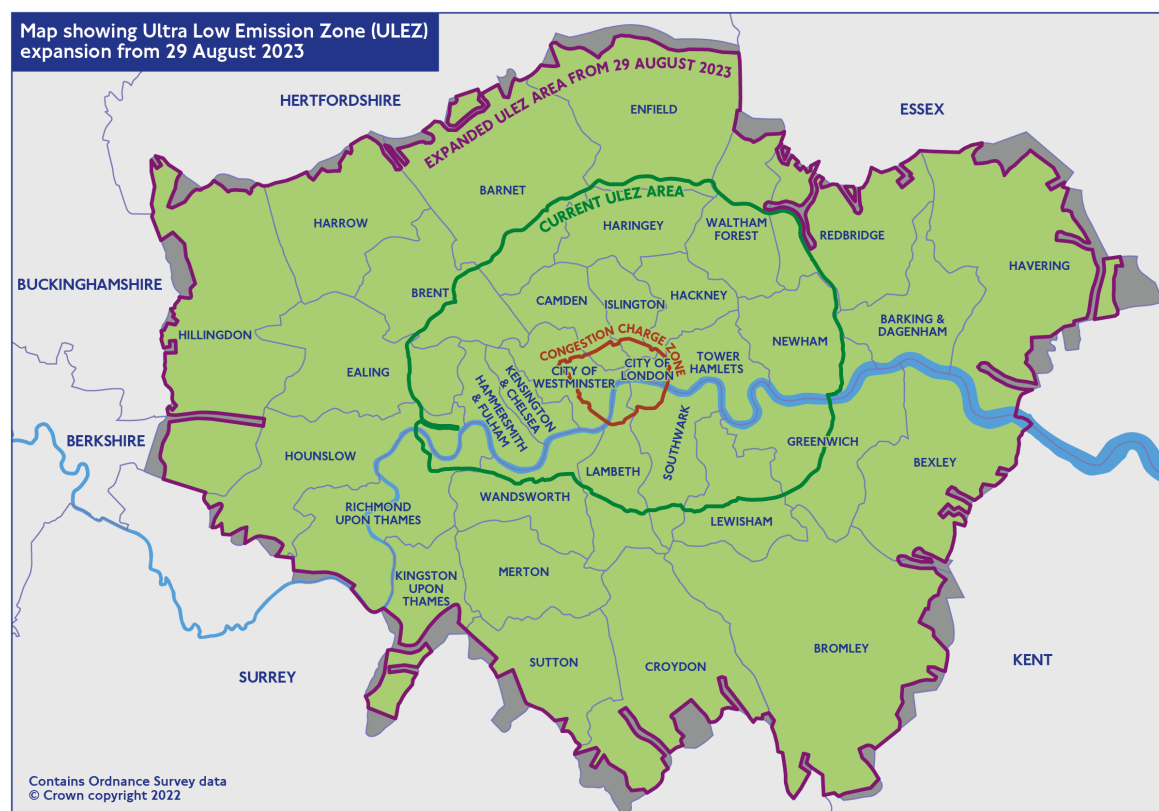
Cars, motorcycles, vans and other specialist vehicles (up to and including 3.5 tonnes) and minibuses (up to and including 5 tonnes) will need to meet the ULEZ emissions standards or pay a daily charge of £12.50 when driving within the zone, including the expanded area from 29 August.

More than four out of five vehicles already meet the standards. But, if you drive a petrol vehicle over 16 years old or a diesel vehicle over 6 years old, you need to check in case you're affected. Use our simple online vehicle checker.

Check your vehicle now To support Londoners through the expansion, the Mayor of London's scrappage scheme is providing financial assistance for those on certain low income or disability benefits. There is also help for London based sole traders, businesses with up to 10 employees and registered charities. The scheme opens on 30 January 2023. For more information on the scrappage scheme and other support, visit our website.

The ULEZ will continue to operate 24 hours a day, 7 days a week, every day of the year except Christmas Day (25 December).

Any money received from the scheme is reinvested into running and improving London's transport network, such as expanding bus routes in outer London.



Visit the interactive map to see if a postcode, location or landmark is in the expanded area. Check your postcode If you drive within the Congestion Charge zone in central London, you will also need to pay the daily Congestion Charge unless your vehicle has an exemption or is registered for a 100% discount. The Congestion Charge zone won't be expanding.

**Chris Grayling MP** for Epsom and Ewell has written to constituents to say:

“I am strongly opposed to the change at this time because of its impact on our area, on pensioners and people on low incomes with older cars and most significantly those seeking treatment at St Helier or the Marsden. I have asked him to reconsider this aspect of the scheme in particular.....

... the plan does not include extending the zone right to the London boundary everywhere. For us the outline ULEZ map says it will not cover the route from Epsom to the M25 via Malden Rushett or from Ewell to Tolworth and the A3 going southwards. There has been some confusion over the status of Rushett Lane and I am checking that with TfL. It will also not include the north end of Stoneleigh and parts of Worcester Park.

.... The target date for the launch is August 29th, though that may slip as some councils are refusing to work with the Mayor to install the cameras that will be needed to make it operational.”

## Surrey County Council Stands Against Scams

**Surrey County Council** has been officially accredited as a “Friends Against Scams” (*FAS*) organisation. *FAS* is an initiative run by the **National Trading Standards** (NTS) Scams Team that aims to protect and prevent people from becoming victims of scams by empowering people to ‘Take a Stand Against Scams’.

The accreditation follows on from some impressive work by Buckinghamshire and Surrey Trading Standards, which has seen them:

- Train 22,269 Friends Against Scams
- Train 161 SCAMchampions
- Train 152 Scam Marshals
- Instal 562 call blockers
- Instal 38 doorbell cameras

The impact of this work can be seen in the financial impact of their interventions which between April 2019 and December 2022 generated savings of £66million.

In addition to the accreditation, Surrey County Council Deputy Leader and Cabinet Member for Communities and Community Safety **Denise Turner-Stewart** officially joined the initiative as a “SCAMBassador”.

SCAMBassador’s protect the public from scams and the damage they cause by working with members of both their community and at national level to educate and support those who may be vulnerable to scams.

Scams affect millions of people across the UK and cost consumers an estimated £5-10 billion of detriment of each year. The people who are targeted are often in the most vulnerable circumstances and the impact on their lives is devastating –



from large financial losses to severe emotional damage which leaves victims feeling intimidated, scared and afraid to be in their home.

Denise Turner-Stewart, Surrey County Council Deputy Leader and Cabinet Member for Communities and Community Safety said: *"I'm delighted to become an official SCAMBassador and to help Friends Against Scams continue their vital work in protecting the public against exploitative and deceitful fraudsters."*

*"Anyone can become a victim of scams but they often target the most vulnerable in society and these criminals and fraudulent practices must be stopped."*
